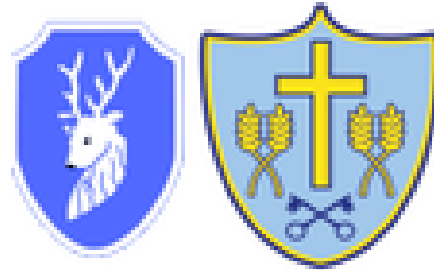

E-Safety Scheme of Work

For The Early Years Foundation Stage and Key Stages 1 & 2

This scheme of work has been produced in order to promote the teaching of E-Safety from the Foundation Stage to Year 6. It draws upon E-Safety guidance that has been produced for schools from Becta (Signposts to Safety – Teaching e-safety at Key Stages 1 and 2)

Many of the resources, activities and lesson plans that the scheme suggests are available from CEOP, Childnet and the BBC. It is suggested that schools use objectives from this scheme and feed them into their existing curriculum planning for ICT and PSHCE.

Online Research	Children confidently and competently use the Internet as a tool for research and critically evaluate websites for their use. Children know that not all information they find on the Internet is accurate or unbiased and develop strategies for identifying the origin of a website. Children are aware of copyright issues and know that not all resources they find on the Internet are legal to use or copy (even if sources are acknowledged).	Children use a range of sources to check the validity of a website. Children recognise that different viewpoints can be found on the web. They critically evaluate the information they use, and understand some of the potential dangers of not doing so. Children are aware of the issues of plagiarism, copyright and data protection in relation to their work. Children select copyright free images and sounds from sources such as the Audio Networks and NEN image gallery.
