

Nursery Admissions Policy 2020

Northern Lights Learning Trust Multi Academy Trust is the Admissions Authority for the school. The Local Governing Body of St. Peter's Elwick CofE Primary School considers the admissions on behalf of the Trust Board.

Initial interest forms are available from the school office and on the school website.

Applications must be made on the school application form 'Admission to Nursery' available from the school office and the school website.

The Admission policy is applied if the number of applications exceeds the number of places.

Children who have an Education Health Care Plan, which names St. Peter's Elwick CofE Primary School as the school, will be admitted.

We will admit 15 applications in accordance with the following criteria in the following order of priority:

1. Looked After children. This refers to children who are looked after by a Local Authority in accordance with Section 22 of the Children's Act 1989(b) and children who were looked after, but ceased to be so, because they were adopted (or became subject to a child arrangements order, residence order or special guardianship order). Parents/carers are asked to send proof as supplemental information with their application form.
2. Looked After children. This refers to children who have been previously looked after, in state care, outside of England, but ceased to be so, because they were adopted. Parents/carers are asked to send proof as supplemental information with their application form.

3. Siblings - children who have an older sibling attending the school, at the time of their application. Sibling refers to brother or sister, half brother or sister, adopted brother or sister, step brother or sister, (foster brother or sister), or the child of the parent/carer's partner. This applies where the child for whom the place is sought is living in the same family unit at the same address as that sibling.

4. Those children who live in the school's admission zone. The postcodes that are classed as being in the admissions zone are attached to this policy.

5. Neighbourhood places - children living near the school will be admitted using the selection criteria, measured who live closest to the school as determined by the straight line distance measurement from the (ordnance survey) address point of the child's home address to the (ordnance survey) address point of the school, using the Local Authority's computerised measuring system). Proof of residency may be sought ie a Council Tax Bill and may be sent in as supplemental information with each application. (no other means of proving residency will be accepted except in exceptional circumstances.)

6. Other children

Tie Breaker: In all criteria, if there are more applicants than places available then priority will be given to those who live closest to the school as determined by the straight line distance measurement from the (ordnance survey) address point of the child's home address to the (ordnance survey) address point of the school, using the Local Authority's computerised measuring system). In the event that two distance measurements are identical, the school will use random allocation to decide which child should be offered the place. The process will be conducted in the presence of a person independent of the school.

Notes and supplemental information:

If there is an incomplete application for a child, in circumstances where parents cannot agree on a preferred school or the main address where the child resides, the governing body will suspend the application until parents agree. This will mean that if the closing date has passed, your child will not be considered in the admission round and if all places have been allocated then your child will not be given a place.

Information given by parents which is found to be fraudulent will result in the offer of a place being withdrawn.

The admissions committee is required by law to consider the information supplied on the application form and the supplemental information asked for. It is very important that you take great care to ensure the details you provide are complete and correct before submitting

them. Any advice or support you require in completing this form can be sought via the school office.

Parents, who are unsuccessful in securing a place for their child at the Academy, have NO statutory right of appeal for nursery.

Children, who are unsuccessful in securing a place at the Academy, will be placed on a waiting list, which will be held by the Academy. Should a place become available then the admissions criteria will be applied again to every child on the waiting list at the time of the vacancy.

In some years where there is pressure on nursery admissions the governing body may admit further children. When this happens there will be a reduction in the number of rising 3 places from January.
